



General agreement

This GENERAL AGREEMENT is between **Luis J. Arias**, President, Owner and Founder of **Mexico Extreme Makeover and Mexico-Direct**, and x John Doe pertaining to the companies of **Mexico Extreme Makeover and Mexico-Direct** in conjunction with **Corporate World Advertising** in combination with **MED CHOICE Financial** in conjunction with **USA/MEXICO Patient Financing**.

x John Doe, as representative of **Mexico Extreme Makeover and Mexico-Direct**, may upon agreeing to and signing this general agreement, received phone calls and e-mails, manage and arrange Membership Enrollment, and promote and market (i.e. broker, assist, train, etc.) for **Mexico Extreme Makeover and Mexico-Direct**. All rights of business or service conducted as an Independent representative of **Mexico Extreme Makeover and Mexico-Direct** are the sole property of Luis J. Arias and are not being used, shared or given to any other entity for any reason.

All business and services performed and contacts made by x John Doe as representative to corporate World Adv. (USA/MEXICO Patient Financing), other financial firms, doctors or hospitals are to be routed through Luis J. Arias for approval. This includes Membership Enrollment for MED CHOICE (USA/MEXICO Patient Financing). As stated above, all business performed and contacts for MED CHOICE (USA/MEXICO Patient Financing), other financial firms, doctors or hospitals are the sole property of Luis J. Arias and are not to be used, shared or given to any other entity for any reason.

A profit of commission per surgery is six percent (6%) above any surgery of three thousand and five hundred dollars (\$3,500 dlls.) or more. Any surgery of less value will be discussed upon procedure or surgery indicated by patient.

No commission earned by employee (independent representative) for personal surgeries through MEM. Discounts will be given within a 4 to 8 month period depending upon employees' performance and surgeries directed and completed to Mexico Extreme Makeover.

After six (6) months of service, this **agreement** will be reviewed with the opportunity, to the representative, of an additional commission by evaluation of the representative's job performance, for fees collected and income generated.

After sixteen (16) months, the percentage of commission will be negotiable depending upon the level of the representative's job performance, for fees collected and income generated.

If any business or sales are conducted with any doctor, hospital or business and charges or paid fees are collected and not discussed or paid through to Luis J. Arias, the representative is in jeopardy of misappropriation and/or embezzlement of funds and monies which will lead to prosecution in the State of California any State of the United States of America and the Nation of Mexico.

This agreement shall be binding upon the parties, their successors, assigns and personal representatives. No representative or employee of above "said representative" shall contact **MED CHOICE (USA/MEXICO Patient Financing)** or their peers or any corporation at any given time or day. This agreement shall be enforced under the laws of the State of California any State of the United States of America and the Nation of Mexico.
